## **Budget Ask FY'25**

The Arc is grateful for Governor Healey's FY25 budget, which includes a \$485 million investment in Chapter 257. This is a necessary step toward addressing the significant challenges facing our constituents with intellectual and developmental disabilities (IDD) including autism and their families. The magnitude of the current workforce shortage plaguing our community requires continued advocacy for rate increases that provide a competitive wage, to allow for recruitment and retention of staff.

Over 3,000 individuals are waiting for services. The FY25 transition age class, with over 1,400 graduates, is the highest in history. Individuals with complex medical or behavioral conditions or who otherwise require 1:1 assistance are the largest underserved or unserved group. These are individuals who need services the most. The isolation and regression, along with caregiver stress, is profound.

## We ask the legislature to:

- 1. Maintain the Chapter 257 reserve at \$390 million, plus the \$95 million designated by the legislature's economic development bill to ensure that direct care staff compensation is no less than a median standard of \$20 per hour.
- 2. Maintain all DDS line item funding to increase access to services.
- 3. Oppose MassHealth PCA proposed eligibility change (requiring 10 hours weekly of ADL support) and restore necessary meal prep time.
- 4. In FY24, the legislature authorized transferability for certain DDS line items. Please continue this language to increase flexibility to reach those unserved.
- 5. Ensure Governor's proposed DESE-DDS funding is noted in the 7061-0012 line item as in previous years (transfer to 5948-0012).
- 6. Pass Nicky's Law Expansion to protect individuals with autism and IDD from abuse and neglect.

**Note:** 1599-6903: Due to biennial rate reviews, the FY23 Chapter 257 figures is the relevant figure for comparison. In addition to the \$390 million, there is \$95 million in the Economic Development Chapter 257 Reserve which also will be used for this year's rate increases. We cannot confirm the DESE figure of \$10.5 million as typically it is not visible in the Governor's budget proposal, but we expect it is there.
