Notes: 1599-6903 - due to biennial rate reviews, the FY'2023 Chapter 257 figure is the relevant figure for comparison. House and Senate Budgets support Gov's 2025 Chapter 257 request of \$390 Million. (\$95 Million from Econ Devel plan already had been approved through FY'25). Senate required **MassHealth to maintain PCA eligibility services in 2025 as in 2023.** House added \$150k OHC in continued investment of health equity but was withdrawn in the Senate Amendment. Advocates for Autism of MA ABA Amendment was passed for \$100K, and Senate included an IAE amendment to address stakeholders concerns about MassHealth's decision to move to a single entity assessment for LTSS services. NOTE -- Total LINE is NOT necessarily meaningful since it includes reserve (yearly fluctuation) AND does not include other relevant line items in other agencies.
