

FY'2024 HOUSE 1 BUDGET REVIEW AND ADVOCACY

Massachusetts

March 2023 marks the start of the 36th month since the announcement of the state of emergency. At that time thousands of persons with disabilities lost access to day programs or related services. Many of those have not been able to return to day services.

In addition, over 3,000 have turned 22 years of age, with the FY'24, transition age class of graduates being the highest in history. Individuals with complex medical or behavioral conditions or otherwise requiring 1:1 assistance are the largest group which is underserved or unserved. These are individuals who need it the most, and the isolation, along with caregiver stress is profound.

In FY'23, the legislature authorized a bridge to the future, including: "re-design the service system to respond to the new needs... in-home or in-community services... new, more fluid service model based on the real-time, individual needs" (5920-2025). It also provided additional funding for day and transportation services, as well allowing DDS to transfer funds across four (4) line items.

Adequate steps, through this legislative initiative are still not being taken to address the individual and family needs and/or accommodations for providers to meet the gaps.

The Arc's Ask for our Annual Legislative Reception Advocacy:

- 1.Please maintain Governor Healey's House 1 proposal for DDS and MassHealth. The DDS funding is essential and the \$200 Million investment in MassHealth day programs is a key part of re-entry for our constituents.
- 2. Help implement the FY"23 language, "Bridge to the Future" and funds for the remainder of this fiscal year.
- 3. Cosponsor and prioritize SD.2086 & HD.3286 An Act relative to rates for workers providing supports and services for individuals with disabilities.. Sen. Barry Finegold, Reps. Sean Garballey and Simon Cataldo. Bill addresses severe workforce shortage for direct support staff, program managers, and clinicians such as nurses. Minimum salary benchmark of the 75th percentile based on our state's bureau of labor statistics. All DDS services & the Mass Health Day Habilitation program

Other Priority Workforce Bills

- 1.SD.2348 & HD.3173 An Act establishing a fund to further educational opportunities for caregivers to adults with disabilities. Sen. Mike Barrett & Rep. Dave Rogers. Creates a pilot to provide free community college to direct support staff with two years of service.
- 2.HD.2455 & SD.1170 An Act relative to family members serving as caregivers. Rep. James O'Day & Sen. Joan Lovely. This bill allows guardians, caregivers, and others with legal standing to be paid for providing AFC and PCA services.

EOHHS separately funds/oversees medical and program transportation through the "Human Services Transportation" department or HST.
